

# ONLINE PRIVACY POLICY AGREEMENT

January 1, 2014

NobleEdge LLC ( NobleEdge) values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with NobleEdge LLC of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

### **Use of Information Collected**

NobleEdge LLC does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

NobleEdge LLC may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. - as necessary to enforce the Terms of Service;
- as necessary to maintain, safeguard and preserve all the rights and property of NobleEdge LLC.

## **Notice to European Union Users**
